Textual Information(1)	Pursuant to Regulation 31A of the SEBI Listing Regulations, 2015 and based on the approval accorded by the Shareholders by way of Postal Ballot on 24th May, 2025, Shareholding of Anuj N. Rathi, Narayandas J. Rathi, NJR Finance Pvt Ltd, Archana A. Rathi and Anuj N. Rathi HUF has been reclassified from Promoter and Promoter Group category to the Public category. Therefore, total shareholding of Promoter and Promoter Group as on 30th June 2025 is reduced from 18774473 shares to 12889203 shares. Based on the approval accorded by the Board at its meeting held on 29th May, 2025, the Company has received No-Objection from both the Stock Exchanges on 15th July, 2025, for reclassification sought by Pradeep R. Rathi, Rahul P. Rathi and Subhadra P. Rathi from Promoter and Promoter Group category to the Public category, which shall be subject to approval of shareholders.
