Textual Information()	During the quarter ended 30th June, 2021, Mrs. Nisha Rathi, member of the Promoter Group sold 318,966 Equity Shares (0.46%), and hence her Shareholding as on 30th June, 2021 reduced to 400,404 Equity Shares (0.58%). Also, as a result of Promoter inter-se transfer, 362,790 (0.52%) Equity Shares held by Late Kusum Ramwilas Rathi were transmitted to Mr. Pradeep Ramwilas Rathi. As a result, Shareholding of Mr. Rathi is 4,186,240 Equity Shares (6.05%). Also, due to the above transactions, total Promoter Shareholding was reduced from 40.03% to 39.57% during the quarter. Also, name of Late Kusum Ramwilas Rathi is removed from the SBO Sheet and Mr. Rathi's Shareholding in the SBO Sheet is changed to 6.05%.
