Accordingly, shareholding of Mr. Rajesh Rathi increased to 4050359 Equity Shares (i.e. 5.85%); (ii) Mrs. Rachna Rajesh Rathi acquired 9120 Equity Shares (i.e. 0.01%) on 28th March, 2021, through open market acquisition, and as a result, shareholding of Mrs. Rachna Rathi increased to 14120 Equity Shares (i.e. 0.02%).
