Textual Information()	During the quarter ended 30th September, 2020, there was an instance for the following promoter inter-se acquisition - 1. A total of 1,89,750 Equity Shares of Rs. 2/- each (i.e. 0.27%) of the TC held by Balkrishna Jagannath Rathi (HUF) were transferred to Ajoy Balkrishna Rathi (HUF)(1,45,325 Equity Shares i.e. 0.21%) and Rajesh Balkrishna Rathi (HUF) (44,425 Equity Shares i.e. 0.06%). Therefore the shares held by Balkrishna Jagannath Rathi (HUF) after the transaction is Nil. 2. A total of 8,45,200 Equity Shares of Rs. 2/- each (i.e. 1.21%) of the TC held by Shri Balkrishna Rathi Family Trust were transferred to Mr. Ajoy Balkrishna Rathi (4,22,600 Equity Shares i.e. 0.61%) and Mr. Rajesh Balkrishna Rathi (4,22,600 Equity Shares i.e. 0.61%). Therefore the shares held by Shri Balkrishna Rathi Family Trust after the transaction is Nil. 3. A total of 1,00,900 Equity Shares of Rs. 2/- each (i.e. 0.15%) of the TC held by Smt. Kusum Balkrishna Rathi were transferred to Mr. Rajesh Balkrishna Rathi. Therefore the shares held by Smt. Kusum Balkrishna Rathi after the transaction is Nil. After considering the above promoter inter-se acquisitions, the total number of Promoter and Promoter Group reduced from 21 to 18, whereas the shareholding of the Group remained intact at 29530529 equity shares i.e. 42.66% Similarly, details of Shri Balkrishna Rathi Family Trust and Smt Kusum Balkrishna Rathi have been removed from the SBO sheet too.
