The Company had applied to the Stock Exchanges for grant of an extension for submission of the unaudited financial results for the quarter ended 30<sup>th</sup> June, 2025 as per SEBI Listing Regulations, 2015 and an intimation was also given to the public at large on 13<sup>th</sup> August, 2025. The Company shall inform the date of the Board Meeting at which the said financial results shall be considered. There is no impact on the financial, operation or other activities of the Company due to levy of said fines by the Stock Exchanges.
